

- iv. In case of dispute or arbitration of any of clause/condition, the decision of the AMASS shall be final.


Procedure for preparing Quotation documents

Subject: Tender for Civil Construction of the Common Facility Centre CFC at Anmol Beekeeping Cluster –Anmol Multipurpose Activities and Social Services Society, Rawatsar, Hanumangarh, Rajasthan (AMASSS)

ANMOL MULTIPURPOSE ACTIVITIES AND SOCIAL SERVICES SOCIETY, the implementing agency under the **Revamped-SFURTI (KVIC & MSME, Govt. of India) guideline**, invites tenders for construction of the Common Facility Centre (CFC) at the Anmol Beekeeping Cluster, Rawatsar.

Qualifying Requirements of Tenderers:

- i. The tenderer should provide satisfactory evidence, acceptable to AMASSS to show that he / organization has adequate capability and experience of construction of work shed for reputed Government / private organization.
- ii. The tenderer should have adequate financial stability and status to meet the obligations under the contract, for which he is required to submit detailed report of similar work done & proof of payments.
- iii. The tenderer/s who are constituents of firm, company association or society must forward attested copies of the constitution of their concern, partnership deed and power of attorney with their tender.
- iv. **Execution of Work:** The successful vendor will have to successfully complete the construction within the given time (months) as agreed by AMASSS from the date of agreement.
- v. **VALIDITY OF OFFER:** The offer shall be kept open for acceptance for a minimum period of SIX MONTHS from the date of opening of tenders.
- vi. **SECURITY DEPOSIT:** Upon acceptance of tender, the successful tenderer must deposit the required amount of security deposit within three weeks time of notification, for satisfactory completion of work. The total amount of Security Deposit shall be as follows: (a) in case of work costing up to Rs 15 Lakh: SD shall be 5% of the contract value. Tenderer must attach DD of in favor of “**Revamped SFURTI – Anmol Multipurpose Activities and Social Services Society” Rawatsar - Hanumangarh (Raj.)** as security deposit (SD). Unsuccessful tenderer will be refunded the security deposit within 21 days from the last date of tender submission. KVIC reserves the right of forfeiture of Security Deposit in addition to other claims and penalties in the event of the contractor's failure to fulfill any of the contractual obligations or in the event of termination of contract as per terms and conditions of contract.
- vii. **EMD:** Successful tenderer will have to deposit 2% of total project cost as Earnest Money (EMD) in DD in favor of “**Revamped SFURTI – Anmol Multipurpose Activities And Social Services Society” Rawatsar - Hanumangarh (Raj.)**”
- viii. If the contractor fully performs and completes the work in all respects to the entire satisfaction of AMASSS and presents an absolute "No Demand Certificate" and returns properties belonging to AMASSS taken, borrowed or hired by him for carrying out the said works, half the amount of Security Deposit will be released to the contractor after deducting all costs, expenses and other amounts that are to be paid to AMASSS under this contracts entered into with the Contractor along with the final bill. Balance half of the amount of Security Deposit will be released only after the Guarantee Period is over.
- ix. The successful tenderer should not sub-contract the part or complete work detailed in the tender specification without written permission of AMASSS.



- x. **NO DEVIATIONS** to the tender conditions will normally be accepted. However, if the tenderer insists for certain deviations to the conditions, financial implication thereof shall be loaded to the quoted price for evaluating the Tenderer's offer.
- xi. **GUARANTEE.** The works constructed by the Contractor shall be guaranteed for a period of 24 (twenty four) months from taking over by AMASSS. During this period the Contractor shall attend to all the matters relating to the Contract work as required by AMASSS.
- xii. **PENALTY FOR DELAY:** If the Work is not completed within the specified period and any extension thereof, the Contractor shall be liable to pay penalty for delay in completion of work @ 0.5% of the total Contract value for every week of delay or part thereof, subjected to a maximum of 10 % of the Contract value without NGO and KVIC being required to establish and prove the actual loss/damage suffered by KVIC on account of such delay.
- xiii. **COMPLETION CERTIFICATES/ NOC FROM LOCAL STATUTORY BODIES:** Contractor has to arrange at his own cost to obtain building/ work completion certificates as required to be obtained from the local statutory bodies of central and state Govt. However, any fees required for obtaining such NOCs shall be paid by AMASSS on production of relevant depository challans/ receipts from such Govt. authorities.
- xiv. **DRAWINGS.** Following drawings are enclosed for reference purpose only. (a) layout of proposed CFC
- xv. All materials to be provided by the Contractor shall be of satisfactory quality.
- xvi. Indicative equipments: Selected tenderer has to arrange Dumpy level, welding machine, hydra, crane, pump, DG set, theodolite, compactor, water tanker etc. at own cost.
- xvii. For progress/ running bill payments, the contractor shall present detailed measurement sheets in triplicate duly indicating all relevant details based on technical documents and connected drawings for the work done during the month/ period under different categories in line with terms of payment. Based on the above quantities, contractor shall prepare the bills and work out the financial value.
- xviii. The Contractor shall comply with all State and Central Laws, Statutory Rules, Regulations, etc. The contractor shall ensure safety to its work force.
- xix. **Terms of Payment:** The Contractor shall be paid monthly running bill of 90% of the value of the work actually executed on site provided the work has been executed to the satisfaction.

The authority for acceptance of tender rests with the competent authority of the NGO and KVIC. Anmol Multipurpose Activities and Social Services Society and KVIC may decide to carry out the construction in a phased manner.






